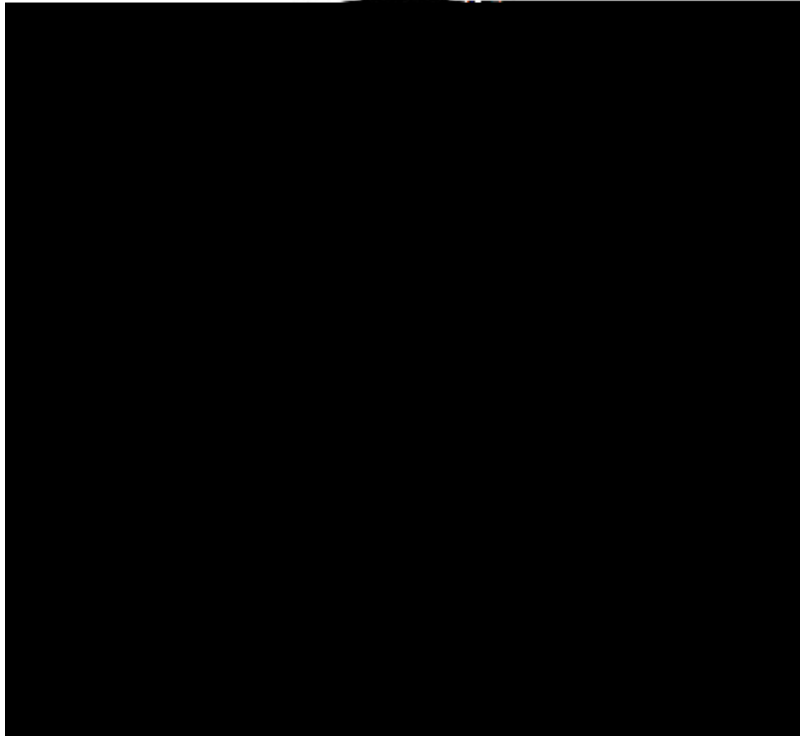

While mask-wearing will no longer be required as of March 2, 2022, those individuals who still choose to wear a face-covering will be permitted to do so. Additional mitigation measures will remain in use for those who prefer the additional protection.

- Diarrhea

The \_\_\_\_\_ continues to encourage students and staff to wash their hands frequently. Teachers will be asked to remind students about proper hand hygiene. When hand washing is not possible, hand sanitizer will be provided.

Schools will isolate and dismiss any student or staff member who has a fever, or other symptoms of \_\_\_\_\_, for follow-up with a healthcare provider. Students suspected of having \_\_\_\_\_ will be isolated in an area separate from others while awaiting transport home by their caregiver. A supervising adult will be present and utilizing appropriate PPE. Over the counter (OTC) COVID-19 antigen tests are available for families and staff.

The \_\_\_\_\_ will continue its frequent cleaning of school buildings. According to the \_\_\_\_\_ daily cleaning of spaces is sufficient to remove potential contaminants. Our custodial staff will continue to clean classrooms, including desks, chairs, and tables each night. Community transmission rates will dictate the frequency of other cleaning throughout the day, including multi-stall bathrooms and other high-touch areas.
