Dear Parent/Guardian,

I am writing in compliance with the provisions of the Open Access Programs to inform you that, because your child receives Title I services, you have the right to request information regarding the professional qualifications of your child's classroom teacher(s). Specifically, included is the right to know the following:

- Whether the teacher is qualified in the content areas and subject areas in which the teacher is teaching;
- Whether the teacher is teaching under emergency or other provisions of the State Education Law;
- The baccalaureate degree major of the teacher and whether another graduate-level certification or degree held by the teacher and field of discipline of the certification or degree; and
- Whether your child is provided services by paraprofessionals.
